



EXPORTER GUIDE TO INDONESIA – OZONE DEPLETING SUBSTANCES

For the attention of importers: This document is intended for exporters in order to explain how to comply with the Indonesia Import Verification Program. It is the responsibility of importers to inform exporters of the existence of the present procedure. Verifications are executed at origin on seller or exporter's request; based on Verification Order applied by the importers in Indonesia.

1. IMPORT VERIFICATION PROGRAM (IVP) FOR OZONE DEPLETING SUBSTANCES TO INDONESIA

LABELLING REQUIREMENTS	<p>Labelling on the goods should be clear to enable users to handle the hazardous chemical safely. International labelling standards for shipments of hazardous goods should be adopted, eg. the <u>Globally Harmonized System (GHS)</u> of Classification and Labelling of Chemicals.</p> <p>For Methyl Bromide, the supplier must include additional labelling on goods which state "For Quarantine and Pre-shipment only".</p>



OTHER REQUIREMENTS	Material Safety Data Sheet / Certificate of Analysis MUST be made available to Cotecna latest after inspection before issuance of the report as required for verification of HS code and CAS no. under the programme.

4. REPORTING REQUIREMENTS

FINAL INVOICE TO SHOW:	FOB, freight, insurance and total value (where applicable) as well as any advance payment.
TYPE OF REPORTS ISSUED:	To seller: Not applicable To KSO SCISI: Draft Laporan Survey (LS)
REPORT PURPOSE:	For KSO SCISI to issue Final LS to importer for Customs clearance purpose.

5. INSPECTION FEES

Verification fees are paid in advance by importers to KSO SCISI at the time of VO application. Nevertheless, Cotecna may invoice the seller in the event of supplementary inspection visits (in vain or unsatisfactory results), inspections beyond normal hours and/or on non-working days. The costs incurred by the seller for presenting the goods for inspection, such as unpacking, handling, repackaging are for the account of the seller. In case if exporter/importer request for additional commercial scope of intervention, Cotecna also reserves the right to charge for these additional scopes.
