EXPORTER GUIDE TO INDONESIA – NON-HAZARDOUS/TOXIC (NON-B3) WASTE

For the attention of importers: This document is intended for exporters in order to explain how to comply with the Indonesia Import Verification Program. It is the responsibility of importers to inform exporters of the existence of the present procedure. Verifications are executed at origin on seller or exporter's request; based on Verification Order applied by the importers in Indonesia.

1. IMPORT VERIFICATION PROGRAM (IVP) FOR NON-B3 WASTE TO INDONESIA

<p>GOODS CONDITION</p>	<p>(1) Non-B3 waste as industrial raw material is the waste of a business and/or activity in the form of waste, scrap or paring which is not included in the classification or category of hazardous and toxic material waste and may be imported if it:</p> <ul style="list-style-type: none"> a. Does not originate from landfill activities (not mixed with soil and clean); b. Is not rubbish and is not mixed with rubbish; c. Is not contaminated with B3 and B3 waste; and d. Is homogeneous (Homogeneous refers to a group of Non-B3 waste materials that are similar and not mixed with another group of Non-B3 waste materials). <p>(2) Prohibited impurities and must not be included in Non-B3 waste as industrial raw materials to be imported are:</p> <ul style="list-style-type: none"> - Materials containing radioactive. - Medical waste like used medicine containers, hypodermic needles, syringes, IV tubes, infusion needles and other medical waste. - Electronic waste, including cell phones, computers, televisions, cables, remote controls, printers, and other electronic materials containing printed circuit board (PCB) and electronic components. - Hazardous and toxic materials. - Waste generated from agriculture use. - Used chemical packaging that is acidic, basic and/or shows hazardous/toxic characteristics. - Rubbish including household rubbish or similar and specific rubbish including diapers, sanitary napkins, condoms, living plants, fruits, vegetables and food scraps. <p>(3) Exporter must ensure that goods are CLEAN and DRY.</p> <p>(4) Waste from AGRICULTURAL and HOSPITAL use are strictly prohibited.</p> <p>(5) Goods must also be FREE from impurities.</p> <p>(6) All goods must be presented for inspection and must be as per goods stated in the VO. Inspector will request for opening of minimum 10% of the total bales/packages per container for inspection. Exporter must provide facilities to open and repack bales/packages immediately after checking. Inspectors will have to place Cotecna tapes/labels on these opened bales/packages before loading into containers. Inspection will be aborted if exporter cannot comply.</p> <p>(7) Country of origin and supply should also be the same as per VO.</p>
<p>OTHER REQUIREMENTS</p>	<p>(1) Exporter should give minimum 3 working days' notice for inspection arrangement from RFI approval and all relevant documents should be submitted, ie. completed RFI form and Packing List.</p> <p>(2) Photos of goods to be inspected must also be furnished before inspection together with the RFI.</p> <p>(3) Inspected quantities must be within the quantity stated as per VO. Otherwise, VO quantity must be amended, or new VO presented before inspection.</p> <p>(4) Exporter must ensure that goods arrival date in Indonesia is within the VO validity date.</p> <p>(5) The Gross and Net weight of the goods to be inspected must be provided in the RFI and documents submitted before inspection. In the event of unavailability of actual weights, the estimated weights must be declared.</p> <p>If any of the above is not fulfilled, inspection request will not be accommodated. Upon completion of the inspection, Exporter must advise Cotecna office the actual final weights as soon as possible.</p>

4. REPORTING REQUIREMENTS

<p>FINAL INVOICE TO SHOW:</p>	<p>FOB, freight, insurance and total value (where applicable) as well as any advance payment.</p>
<p>TYPE OF REPORTS ISSUED:</p>	<p>To seller: Security Label, if required by the seller upon submission of Final Invoice. To KSO SCISI: Draft Laporan Survey (LS)</p>
<p>REPORT PURPOSE:</p>	<p>For KSO SCISI to issue Final LS to importer for Customs clearance.</p>



OTHER REQUIREMENTS	<p>(1) Exporter's Statement Letter (ESL) is a required document to be submitted before issuance of the LS. This must be prepared with Exporter's letterhead. The template is available from Cotecna offices and Exporter must submit this latest after inspection to facilitate issuance of Draft LS.</p> <p>(2) 1 LS will be issued for 1 inspection done at 1 location.</p> <p>(3) Exporter should submit the Final Documents with the final gross and net weight as soon as available after inspection for Draft LS issuance.</p>

5. INSPECTION FEES

Verification fees are paid in advance by importers to KSO SCISI at the time of VO application. Nevertheless, Cotecna may invoice the seller in the event of supplementary inspection visits (in vain or unsatisfactory results), inspections beyond normal hours and/or on non-working days.

The costs incurred by the seller for presenting the goods for inspection, such as unpacking, handling, repackaging are for the account of the seller.

In case if exporter/importer request for additional commercial scope of intervention, Cotecna also reserves the right to charge for these additional scopes.

For Non-B3 waste, additional billings may apply. Please contact Cotecna inspection offices for more information.
